

Subject: Request for filing a complaint (Zero-FIR) in c/w reconnection of electricity against me.

Sir,

With due respect, I would like to report a cognizable offence carried out against me and my family on 3<sup>rd</sup> May 2023 at around 5:00pm wherein a large gathering mob of meitei community conspired and instigated by Meitei Leepun & Arambai Tenggol of valley based CSOs attacked the Kuki-Zo community in JNIMS Hospital where I am working and rendering me in a state of homelessness. Fearing loss of lives and being in a state of vulnerability, I along with my family on 4<sup>th</sup> May 2023 evening at 6:00pm fled to 1<sup>st</sup> MR Campus and taken refuge there. Then on 7<sup>th</sup> May 2023 at around 1:00pm we left for Guwahati by flight and subsequent after staying in Guwahati for 3days we reached Delhi on 10<sup>th</sup> May 2023 at around 4:00pm. Then from Delhi ultimately, I reach my permanent residence at I B Road, Hiangtam Lamka, Churachandpur. I Therefore, could not file the F.I.R on time due to delayed in reaching my residence.

That, the JNIMS Quarter Block B-10 Porompat Imphal East where I stay was allotted to another person. Regarding my assets/properties estimated at Rs. 8,67,000.00 (Eight Lakhs Sixty seven Thousand Only) were removed by unknown miscreants and the where about is not known. (List of properties Enclosed)

I, therefore, seek your kind intervention to register FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
