On the 04th of May 2023 at about 04:30 a.m. a group of Meitei/Meiteis miscreants attacked our Village by using firearms. In the process they looted and vandalized all the properties.

That, it is also worth mentioning that these criminal activities have caused agony and incurred a huge loss estimated at about Rs. 23,00,000/.( Twenty Three lakhs) Only.

I was late in submitting this application as I was in different remote areas for months.

Therefore I earnestly request you to kindly register a ZERO FIR and book the perpetrators under the appropriate section of law.
