



Subject : Report on crimes of Vandalism and looting of properties.
Sir,

With reference to the above cited subject, I have the honor to report to you as follows :

I, Lalam Haokip aged about 50 years D/o (L) Simkhojam Haokip of Near KBC Centre Church Nongpok Ingkhol New Lambulane Imphal East District, PS - Porompat. I would like to inform that I had stayed with my sister namely Lhingboi Haokip, in a rented house owned by one Lamneihoi Lipheng.

On the 04th of May 2023 at about 04:30 a.m. a group of Meitei/Meiteis miscreants attacked our Village by using firearms. In the process they looted and vandalized all the properties.

That, it is also worth mentioning that these criminal activities have caused agony and incurred a huge loss estimated at about Rs. 23,00,000/-(Twenty Three lakhs) Only.

I was late in submitting this application as I was in different remote areas for months.

Therefore I earnestly request you to kindly register a ZERO FIR and book the perpetrators under the appropriate section of law.
