



Subject: Complaint report regarding looting of my valuable household items on 17 September 2023 at Evangelical Synod Church Campus, New Lambulane 2nd street, Opposite to ECA City Church Imphal, Manipur.

Dear Sir,

With all due respect, I (Lalkhongam, age 61, son of Late Chungsat) would like to inform you that on 17 September 2023, suspected Meitei people broke down the door of my abandoned house and looted all my valuable household items that cost an amount of Rs 10,0000 (i.e Furniture = Rs 2,00,000, Kitchen material = Rs 2,00,000 Clothes = Rs 1,50,000, Electronics = Rs 2,00,000, Cash = Rs 50,000 Others = Rs 2,00,000) from my house where I stay there as Care Taker of the Church. All the valuable household items were looted and stolen from my room which is located at **Evangelical Synod Church Building, Ground floor, Opposite to ECA City Church, 2nd Street, New Lambulane, Imphal.** I was compelled to left my room on 4th May 2023 due to ethnic violence broke out between Meitei and Kuki since May 3rd 2023.

I, therefore request you to look into the matter and file the F.I.R. at your police station for further necessary action that needs to be taken.
