



1. That, I Lienminlal Neihlsal, Aged 39 H/o Chinneichong belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989. Whereby, My Shop had Located at New Checkon, P.S Porompat, District Imphal East. *(signed by)*

2. That, on 4th May 2023, at 12 noon, huge contingent of Armed Radical Meitei/Meiteis, Arambal Tenggol and Meitei Leepun attack our Village and in the process looted/vandalized/burnt our house and properties.

3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be 34 Lakhs 55 Thousands only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at District Head Quarter, Tuibong, Churachandpur.

So, I could not make the said report on time due to present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
