- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are Taking refuge at Kingkin Village, Churachandpur.

So, I could not make the said report on time due to present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
