

With reference to the above cited Subject, I have the honor to report to you as below:

1. That, I Hoinu Haokip, Aged: 42 D/o Ngamlun Haokip belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989. Whereby, I had stayed as Rented at New Checkon, P.S: Porompat, District: Imphal East. (owned by Iktombi)
 2. That, on 3rd May 2023, at 4pm, huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our Village and in the process looted/vandalized/burnt our house and properties.
 3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be 28 Lakhs only.
 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at B.Vengnom Relief Centre, Churachandpur.
- So, I could not make the said report on time due to present situation which unable me to do the report.
- I, therefore, request you to register on FIR and bring justice.
