



I, Suanlianhang aged about 36 years S/o Langchinkai of Chahsad Avenue near KBC Centre Church Imphal East District, Manipur, PS-Imphal. I would like to inform that I had stayed, in a rented house owned by one Mr. Seilen Haokip.

On 4th June 2023 at around 4 :00 P.M a group of meiteis miscreants looted and Vandalized all the properties.

That, it is also worth mentioning that these criminal activities have caused agony and incurred a huge loss estimated Rs.18,00,000/.(Eighteen lakhs) Only.

I was late in submitting this application as I was in different remote areas for perpetrators under the appropriate section of law.
