



Subject: - Report on crimes of Unlawful Displacement, Looting household items/movable assets and Discrimination of Scheduled Tribe.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows;

That I am a scheduled tribe, belonging to the Vaiphei Tribe, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under *The SC/ST (Prevention of Atrocities) Act, 1989*, and I am a permanent resident of Lingsiphai Village, P.O., P.S. & District- Churachandpur, Manipur.

That, due to the on-going/prevailing ethnic crisis in and around Imphal Valley, my family deserted our rented house owned by R.K. Bopen (9862055748) located at Purana Rajbari Leikai, Nongmeibung, P.O. & P.S- Porompat, district- Imphal East on the 4th of May, 2023 at around 8:30 AM, taking refuge at 1st Manipur Rifles located at Jail Road, Old Lambulane, P.O./P.S.- Imphal Police Station, district- Imphal East in order to save themselves the majorities Meetei/Meitei community.

That, on the 9th of July, 2023 at around 8:30 AM, my wife namely, Mrs. Zenlamniang, was on a phone call with the landlord's wife, they it came to our knowledge that a group of criminal's belongings to the Meetei/Meitei community had looted and vandalised my household items/ movable assets on the 8th of July, 2023 at around 6:30 PM, that includes;

That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.18,50,000/- (*Rupees Eighteen Lakhs Fifty Thousand*) only, inclusive of the said household properties along with the said Two-Wheeler.
