



This unlawful attacked put me and my family members 2 male and 8 female in grave danger. Therefore we had fled to D.Phailen Churachandpur District, Manipur.
Total worth of value destroyed Rs. 60/- lakhs approx.

I therefore seek your timely intervention and register FIR.
