



Subject :- Report on Looting of household items/assets, and discrimination of Schedule Tribes.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Lallienkhum** aged about 53 years S/o **Dosang** Belonging to the **Hmar** Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **New Checekon, Maring Lane, Imphal-East District Manipur. P.O., & P.S., Porompat**.
2. That at about **3:30 am** on the **8th May 2023**, due to the ethnic violence in the state , I and my family have to run for our lives, leaving behind our rented house owned by Mr. **Dr L Infimate** at the above mentioned address, along with all our household items and belongings. and took shelter at **Lamphel 2nd Manipur Rifles Camp**. And in the process some unknown miscreants have looted our rented house, including all our Household items and belongings.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 5,00,000/- (Rupees Five Lakhs) only**
4. Fortunately I and my family managed to escaped from the Violence, and now currently taking refuge at **Saidan Village Churachandpur**.
5. That, I am filing this information lately because I was at different place And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
