Subject : Report.

Sir,

With due regards, I, the undersigned have the honour to state that today i.e. 17/02/2024 at about 05:30 am conducted Cordon and Search Operation (CASO) by a combined team of District Police, Thoubal led by Shri Okramcha Wangkhomba, MPS, Addl. SP(Ops)/TBL assisted by DSP(Ops)/TBL, OC/CDO-TBL, OC/NSK-PS including 33 AR COB Thoubal and 5 teams of CDO/TBL under the supervision of Sr. SP/TBL at Toubul and B. Phainom villages. During the course of house to house search operation at Toubul village visited 70 (seventy) Nos. of houses and verified 115 (One hundred fifteen) Nos. of individuals whereas no any seizures or arrest were made.

On further course of search operation at B. Phainom village found the undernoted articles i.e. (1) 01 (one) No. of 81 mm Improvised Mortar, (2) 01 (one) No. of SBBL, (3) 01 (one) No. of 36 HE Hand Grenade (can be used as explosive), (4) 02 (two) Nos. of Hand Grenade No. 90 MK-3, (5) 01 (one) No. of 38 mm Anti-Riot Rubber Bullet, (6) 02 (two) Nos. of Tear Smoke Shell Soft Nose, (7) 01 (one) of 2 inch Mortar Shell with case, (8) 02 (two) Nos. of 40 mm Lathode Bomb, (9) 02 (two) Nos. of 7.62 mm ammunitions, (10) 05 (five) Nos. of 5.56 mm Blank Cartridge, (11) 01 (one) No. of SLR magazine and (12) 01 (one) No. of Improvised Exploded Shell have been seized from the jungle of aforesaid village i.e. B. Phainom village at 06:45 am. The massive search Operation was conducted from 05:30 am and continued till 07:10 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
