Today i.e 06/04/2024 at around 07:10 pm, a huge mob consisting about 600/700 peoples including male and female suspected to be supporters of Moirangthem Totomshana Nongshaba S/o (L) M. Tombiyaima Singh of Heirok Part-II Mayai Leikai, who is the Intending Independent candidate of 18th Lok Sabha Election, 2024 (Inner Manipur Parliamentary Constituency) by holding deadly weapons like iron rods, Wooden logs and stones etc. were unlawfully assembled in front of Heirok Police Station gate located at Heirok Part-II Mayai Leikai, District-Thoubal, Manipur regarding service of summon to one Moirangthem Totomshana Nongshaba S/o (L) M. Tombiyaima Singh of Heirok Part-II Mayai Leikai, Pujari Chuthek, PO-Wangjing, PS-Heirok, District-Thoubal, Manipur by police team of Imphal West district in c/w case FIR No. 220(04)2024 IPS U/s 120-B/153-A/500/503/505/506 IPC & 125 RP Act. The unruly mob stormed all the side of Heirok PS and pelting stones inside the campus of Heirok PS and vandalized some properties of Heirok PS. As a result of which 2 (two) numbers CCTV cameras of Heirok PS were totally damaged and also front & side glasses of 4 (four) vehicles were vandalized by the unruly mob as well as electric wire fitted at Heirok PS were disconnected by the unruly mob. Later on, the mob has been dispersed by police teams by minimal use of required force at around 10:15 pm.

Hence, a suo-motto case under FIR No. 04(04)2024 HRK-PS U/s 147/148/149/341/186/427 IPC has been registered for investigation.
