I, the undersigned have the honour tostate that large number of innumerable unidentified groups of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki Militants groups stormed to all the Meitei inhabited areas of Motbung on 3rd day of May,2023 at around 6:30 p.m. The said unidentified groups vandalized/burnt down my rent house/shop and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 8,20,000/-(Rupees Eight Lakhs and twenty thousand)only and all important documents. After the said unfortunate incident/mob violent, my family are fleeing from our Rent house and taking shelter at Ch. Tulasing High School, Awang Sekmai, Koujengleima Relief Camp thereafter I alongwith my wife and two sons returned at my permanent hometown.

It is therefore, prayed that the Respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

This may treated as O.E for registration/lodging of FIR. Delay in lodging complaint is due to the prevailing Law & Order situation of Manipur.
