Subject:- Request for taking necessary actions against (1) Ningombam Khelen Singh, aged about 28 years S/o N. Inaobi of Khewa Phurju, Sagolmang, (2) Loya, (3) Irom Davidson, aged about 27 years S/o I. Daju of Kakwa Huidrom Leikai, (4) Pheiroijam Lalmohon, aged about 35 years S/o Ph. Khogen of Takyel Kolom Leikai, (5) Laishram Bedan, aged about 25 years S/o L. Dolen of Khewa Phurju Mayai Leikai.

Sir,

With due respect and honour I beg to state a few lines that on 19/03/2024 at about 11:30 Am the mentioned persons namely- (1) Ningombam Khelen Singh, aged about 28 years S/o N. Inaobi of Khewa Phurju, Sagolmang. (2) Loya, (3) Irom Davidson, aged about 27 years S/o I. Daju of Kakwa Huidrom Leikai, (4) Pheiroijam Lalmohon, aged about 35 years S/o Ph. Khogen of Takyel Kolom Leikai, (5) Laishram Bedan, aged about 25 years S/o L. Dolen of Khewa Phurju Mayai Leikai and their team entered my house with weapons such as AK-47 Pistols, etc. and threaten to mi including my family members and son and also my own Aunty and mothers house of Mekola. That they asked my husband and I replied that he is in Guwahati for his medical treatment thereafter they started shouting at me and my family. That thereafter he said Ningombam Khelen cock his Pistol and put on my forehead and further said that if I don't produce my husband. I may be kill at any point of time including my family members. That after seeing the acts done by them to me, my son and his friends rush towards me and requested them for not do such acts. But inspite of listening to the words of my son, me and his friends they started stapping to my son friends that time I told to Mr. Khellen not to beat to his friends my son but they didn't listen.

Thereafter they further threaten to me and family that if don't produce my husband Sanjit Konthoujam before their Party/Organisation UNLF(P), they will burn down my house and would surely kill my husband Sanjit Konthoujam whenever they met. That after they took my son bike being model no. Apache RR 310 being Regn. AS01EH 3409, red in colour and left the place hurriedly.

That it is pertinent to mention that on 14th March, 2024 at about 4:30 Pm they kidnapped my husband Sanjit Konthoujam from Takyel Kolom Leikai of Pheiroijam Lalmohon House and took to Khabi then to a house located at Langol Game Village and beaten him by 9/10 peoples started beating and tortured him one by one nearly 8(eight) hours and tie his hand and legs until and unless become bluish in colour and put in a corner of house. That after brutually torturing my husband they snatch the wrist Watch, Wallet, Santro Car (red) being Regn. No. MN0P7109, Realme mobile Phone, Laptop, CCTV camera modem including ATM Cards and other valuable documents. They also took several video graphs and signature on some blank papers and released my husband on the next day morning i.e. 15th March, 2024 at about 8:30 Am. They further started that my husband should give a sum of Rs. 25(twenty five) Lakhs to their Organisation on the same day i.e. 15th March, 2024 till 5:00 Pm and if he fails to pay they said amount there will be bad consequences in near future. That due to the acts done by them my husband is now undergoing treatment at Dispur Hospital in Guwahati.

So, I therefore request you to take necessary legal actions against them in the interest of natural justice. Enclosed:- Photos.
