Subject: Report on stolen of goods from my trucks.

Sir,

With due respect, I have the honour to report that my Tata trucks bearing regn no. AS01PC-0594 & Tata truck bearing Regn.AS01PC-0595 both loaded with cold drinks (beverages) while heading towards Imphal from Guwahati have reached Saparmeina. Kangpokpi District, Manipur in the evening of 03-05-2023. The trucks were not allowed to move further towards Imphal because of the violence incident in the nearby area and the Trucks were stranded at Saparmeina. During the night, situation got worsen in the area and as such both the drivers left the truck to save their life from the violent mob to a safer location. All the loaded goods (cold drinks) in both the trucks were found stolen by unknown miscreants on 08-05-2023. The value of loss properties loaded in Tata truck no. AS01PC-0594 is Rs 23,43,553 and Tata truck No. AS01PC-0595 is Rs 24,83,830/-. Total: Rs 48,27,383/- (Rupees Forty eight lakhs twenty seven thousand three hundred and eighty three only) approx.

I could not report the matter in time due to the prevailing law and order situation of the state.

I, therefore request you to take necessary action against the culprit according to law.
