

Subject: Report.

Sir,

With due respect, I have the honour to state that, on the 2nd June 2023 at around 4:50 PM. Unknown miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol, Meitei Leepun, Extremist volunteers by holding deadly weapons like Automatic Rifles and Bomb attacked our village i.e Bethel Village under Kangchup Geljang Sub Division, Kangpokpi District. They robbed, demolished and burnt down 32 houses along with household goods and properties and important documents, public properties etc in the village.

The following are the public properties destroyed by the miscreants:

- (i) Church Building worth Rs. 10 Lakhs - Partly demolished.
- (ii) Church Guest House worth Rs. 30 Lakhs - Building & Properties totally damaged.
- (iii) Community Hall worth Rs. 90 Lakhs - Building & Properties totally damaged.
- (iv) Church Pastor Quarter worth Rs. 10 Lakhs - Building & Properties totally damaged.
- (v) Legal Aid Clinic Building worth Rs. 5 Lakhs - Building & Properties totally damaged.
- (vi) Church Kitchen worth Rs. 5 Lakhs - Building & Properties totally damaged.
- (vii) K. Bethel Primary School worth Rs. 30 Lakhs - Building & Properties totally damaged.
- (viii) 32 (Thirty two) houses in the village worth Rs. 5 Crore - Building & Properties totally damaged.

The total amount of destroyed properties are estimated at Rs. 6,80,00,000/- (Rs. Six Cores and Eighty Lakhs).

The incident could not be reported immediately due to insecurity of our lives and volatile situation in the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.


