



Sir,

With due respect, I have the honour to state that, on the 2nd June 2023 at around 6:00 PM. Unknown miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol, Meitei Leepun, Extremist volunteers by holding deadly weapons like Automatic Rifles and Bomb attacked our village i.e. K. Songlung Village under Kangchup Geljang Sub Division, Kangpokpi District. They robbed, demolished and burnt down 5 houses along with household goods and properties and important documents etc in the village.

The total amount of destroyed properties are estimated at Rs. 1,00,00,000/- (Rs. One Core only).

The incident could not be reported immediately due to insecurity of our lives and volatile situation in the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime. Thanking you Sir.
