

I have the honour to report that on 03/05/2023 at Kangpokpi District, Manipur a large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely burned down my houses and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Kutch House Burnt - Rs. 10,000,00/-
2. Plank Store (Upak Dukan) - Rs. 2,000,00/-
3. Beds 2, 1 bed box, 1 Gas box, Dressing table, Almirah, 1 TV sets with Box, Washing machine, Stand Fan, Gas Stove, 3 Cylinder, Utensils, clothing, Jewellery and Cash amount - Rs. 3,83,000/-
4. Documents (Aadhar card, PAN card, Voter card, Ration card, Bank document, OBC certificate, Educational certificate - 10, 10+2)

Total approximate value is about Rs. 15,83,000/- (Fifteen lakhs Eighty three thousand).

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
