I, the undersigned would like to state that my eldest daughter Miss Lhaincihat Hangshing(20) has been kidnaped by Mr. Seijahao Kipgen S/O Joseph Kipgen of SM. Munnom Village, Mr. Paominhao Kipgen S/O Satlal Kipgen of Moljol Village, Mr. Lamkhongam Haokip S/O Henthang Haokip of SM. Munnom Village and Mr. Lunminsei Kipgen S/O Paokholen Kipgen of SM. Munnom Village in an Ecco Van (Plate Unknown) at around 9:30 PM to 11:00 PM on 4<sup>th</sup> January 2023, Wednesday while she was going to new year celebration social gathering at SM. Munnom village.

It is learned that she was screaming and crying while she was forcibly kidnapped by the above mentioned individuals, after that we the family do whatever we could to get back her safe and sounds but failed to do so. Moreover, we inform the kidnappers parents as well that they should take initiative and responsibility to convince their children's to bring back their daughter and settle the issue according to our Thadou-Kuki customary law but they fail to produce her. They agreed to bring her back before 5<sup>th</sup> January 2023 (Thursday) 12:00 PM but they fail again.

So, it is finally decided to report the incident to the Police station so that the Police may kindly help us to recover our daughter safe and sound. Therefore, we kindly request you to help us and punished the culprit according to law, so that such types of crime will not be committed again in our society. For which act of your kindness we the family shall remain grateful to you.
