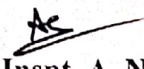

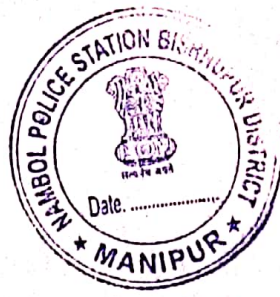

Today i.e. 05/01/2024 at 6:15 pm received a reliable information that on the same day at around 6:10 pm, one Scooter TVS Jupiter bearing regd. No. Nil ridden by one unknown rider which was proceeding from Bishnupur side towards Nambol side was dashed by one unknown car driven by one unknown driver which was also proceeding from the same direction at Oinam Makha near Jai Jaganath Oil Pump along Tiddim road. Subsequently, due to impact, the said TVS Jupiter again dashed to one unknown male cyclist who was also riding from the Keinou side towards Oinam side due to rash and negligent driving on the part of the unknown driver of unknown car and fled away by taking advantage of darkness. As a result of which, the unknown rider of TVS Jupiter received injury and the unknown male cyclist also received minor injury on their persons and evacuated to hospital for medical treatment. The involved TVS Jupiter and bicycle were also damaged.

Hence, a regular case under FIR No. 01(01)2024 NBL-PS U/S 279/338/427 IPC is registered on suo moto for investigation.
