Today i.e. 24th March, 2024 at around 7:10 am, after receiving a reliable information from 33 AR (F-Coy) Maibam Lotpa Ching which was further corroborated from our own source regarding the presence of militants hideouts in general areas Nambol Naorem, Nambol Oinam and Mantha Ching. Bishnupur CDO teams led by P. Sanjoy Singh, MPS/DSP (CDO-1) and assisted by Sl. S. Kishorjit Singh, HC. O. Jayenta Singh and Hav. No. 1711685, A. Johnson Singh under the overall supervision of Ksh. Ravikumar Singh, IPS, SP/Bishnupur, Amarjit Lamabam, Addl. SP (Ops) Bishnupur conducted an extensive searched operation in Oinam Yumpham/ Oksoi. During the searched found one cartoon box and on opening the said cartoon box the following articles viz. (1) one 7.65 mm pistol marked as Made in USA with two magazines (2) 8(eight) nos. of H.E grenade No. 36 (3) 2(two) nos. of Chinese hand grenades (4) one Kenwood hand held set bearing No. B0983245 with antenna and (5) one medical kit.5 were detected.

The above mentioned arm, grenades, WT set and medical kit which were suspected to be hidden by militants were seized at 8:45 am by observing formalities and handed over to Nambol PS for further necessary action.
