



The properties that were burn down and looted are as follows:

1. Mobile Store Burnt –
2. New Mobile Smartphone (8 Pcs) – 1,40,000/-
3. Mobile Accessories - Rs. 2,35,000/-
4. Mobile machinery Items - Rs. 1,3700/-
5. Second hand Mobile 37 Sets - Rs. 1,40,000/-
6. Laptop - Rs. 60,000/-

Total approximate value is about Rs. 7,12,000/-approx.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.


