The properties that were burn down and looted are as follows:

1. Semi Pucca House Burnt - Rs. 3,00,000/-
2. Iron Godrej - Rs. 15,000/-
3. Almirah - Rs. 10,000/-
4. Gas Items - Rs. 9,000/-
5. Cash - Rs. 29,000/-
6. Gold Jewellery - Rs. 21,000/-
7. Clothing - Rs. 20,000/-
8. T.V set - Rs. 15,000/-
9. Utensils - Rs. 20,000/-
10. Syntax - Rs. 3000/-
11. Furniture - Rs. 25,000/-
12. Documents (Aadhar card, Voter ID and ATM with passbook)

Total approximate value is about Rs. 4,69,000/- approx.


