



I have the honour to report that on 05/05/2023 at around 8:00 am the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, vandalized my house and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were destroyed and looted are as follows:

1. Semi Pucca House Vandalized
2. Wooden Almirah 4 Faces and 2 faces – Rs. 50,000/-
3. Iron Godrej - Rs. 15,000/-
4. Refrigerator and Washing Machine – Rs. 19,000/-
5. Double Bed and Single Bed - Rs. 45,000/-
6. TV - Rs. 10,000/-
7. Utensils, Sofa Sets - Rs. 35,000/-
8. Gold and Cash Rs. 1,10,000/-
9. Clothing, 2 Cylinder and Stove - Rs. 30,000/-
10. Documents (Aadhar card, Bank passbook, 10 certificate, Voter card etc)

Total approximate value is about Rs. 4,34,000/-approx.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.
