

I have the honour to report that on 04/05/2023 at around 4:00 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has completely burnt down my house and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were destroyed and looted are as follows:

1. Kutcha House burnt -Rs. 7,00,00/-
2. Wooden Beds 2 nos. – Rs. 50,000/-
3. Wooden Bed Single -Rs. 15,000/-
4. Steel Godrej 2 nos – Rs. 34,000/-
5. Tullu Big -Rs. 6,500/-
6. Electronic Items -Rs. 30,000/-
7. Sintex (1000 l) - Rs. 6,000/-
8. Gas Stove, 2 Cylinders and box -Rs. 20,000/-
9. Utensils -Rs. 25,000/-
10. Clothing Rs. 80,000/-
11. Jewellery and cash -Rs. 1,22,000/-
12. Documents (Aadhar card, Bank passbook, ATM card, Voter ID, Certificates)

Total approximate value is about Rs. 10,88,500/-approx.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


