

The properties that were destroyed and looted are as follows:

2. Steel Godrej Almirah -Rs. 18,000/-
3. Wooden Beds (Double 2 and Single 2) - Rs. 69,000/-
4. Wooden Almirahs (2 Nos) - Rs. 50,000/-
5. Washing Machine -Rs. 16,000/-
6. TV -Rs. 20,000/-
7. Refrigerator -Rs. 15,000/-
8. Clothing - Rs. 90,000/-
9. Gold -Rs. 1,20,000/-
10. Cash -Rs. 50,000/-
11. Computer -Rs. 26,000/-
12. Furniture -Rs. 1,00,000/-
13. Gas Cylinder 3 and Stove -Rs. 14,000/-
14. Syntax (500 I) 2nos -Rs. 5,000/-
15. Utensils -Rs. 70,000/-
