

I have the honour to report that on 05/05/2023 at around 8:00 am the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has vandalized my house and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were destroyed and looted are as follows:

1. Kutch House Vandalized -Rs. 8,00,000/-
2. Wooden beds (4nos) – Rs. 70,000/-
3. Wooden Almirah 1, 2 Steel Godrej, electronic items -Rs. 1,00,000/-
4. Washing Machine –Rs. 15,000/-
5. 2 nos. Gas stove, 2 nos. Cylinder and box -Rs. 30,000/-
6. Utensils and Clothing -Rs. 1,30,000/-
7. Jewellery (2 san) -Rs. 50,000/-
8. Cash amount -Rs. 30,000/-
9. Local Tata (MN-01-4607) Owner Name :Nahakpam Inderjit Khetrigao, Ex-MLA # 9774230081 - Rs. 5,00,000/-
10. Documents (Aadhar card, Job card, Ration card, Voter ID and certificate)

Total approximate value is about Rs. 17,25,000/-approx.
