Sir,

I have the honour to report that today i.e, 14/02/2024 at about 9.15 pm some of our members, were brutally assaulted with attempt of murdering by 4 (four) individuals namely i.e. 1) Ph. Musha age about 35 yrs S/o. Md. Adol, 2) Md. Nawas Sharif aged about 28 yrs S/o. Late. Md. Jamaruddin, 3) Md. Imran aged about 27 yrs S/o. Adol of do- and 4) Md. Azhar aged about 25 yrs S/o. Md. Islauddin all are residence of Lilong Haoreibi Makha Leikai. It is to be noted the 04 (four) persons were in possessive of short gun and knives. In this attempt to murder our member one DP. Sadique aged about 31 yrs S/o. DP. Nawab Ali of Lilong Haoreibi Makhal Leikai was severely injured. He was hit by the bud of the gun and attacked by knives together by this persons.

This untoward incident was happened while our members were on a drive to give awareness on drug peddlers of our localities i.e. Lilong Haoreibi Makha Leikai. When DP Sadique and our members were having some conversation among themselves this 04 (four) persons started to attacked with their full potential.

It is therefore requested to take up necessary legal action against the above noted culprits.
