With due respect, I have the honour to report the following few lines that, I am resided at Torbung Bangla. On 3rd May, 2023 at around 6:00 pm, my house was burnt down as well as looted by large number of kuki rioters and suspected to be Kuki militants with sophisticated weapon.

The properties that were burn down/looted are as follows:

1. House – Rs. 30,00,000/-
2. Furniture items Rs.20,000/-
3. Godrej Almirah Rs. 40,000/-
4. kitchen items Rs.100000/-
5. Garment and jewelry (12 san) Rs.1,80,000/-
6. cash Rs. 50,000/-
7. Electronic items Rs.32,000/-
8. Rice (Phou)(80 bags) Rs. 96,000/-
9. Clothing's Rs. 100000/-
10. Hen & duck – Rs. 50,000/-
11. Other important documents

Total approximate value is about Rs. 36,68,000/-

Regarding the matters I couldn't able to report to the concern PS i.e. Phougakchou Ikhai Police Station till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is, therefore, requested you to kindly take up necessary legal action.
