

I have the honour to report that on 05/05/2023 at around 8:00 am the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has completely burnt down my house and looted much of my properties located at Motbung Mamang Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Semi-Pucca House Burnt -Rs. 10,00,000/-
2. Local Truck - Rs. 4,50,000/-
3. Furniture -Rs. 50,000/-
4. Utensils and Kitchen items -Rs. 50,000/-
5. TV sets - Rs. 20,000/-
6. Laptops - RS. 35,000/-
7. Gold -Rs. 50,000/-
8. Cash amount -Rs. 70,000/-
9. Cylinder with gas stove -Rs. 20,000/-
10. Washing Machine -Rs. 14,000/-
11. Refrigerator -Rs. 15,000/-
12. Rice -Rs. 30,000/-
13. Clothing -Rs. 50,000/-
14. Documents (Aadhar, Voter ID, ATM and Bank passbook)

Total approximate value is about Rs. 18,54,000/-approx.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.
