



Subject:- First Information report (FIR) reg.events of 26-03-2023. Reference Agreement dated 25-03-2001 and our letter to Officer Incharge, Leimakhong Police Station dated 11 March 2023 copy enclosed as annexure A and B respectively.

Sir,

This is to submit to your goodself the following few lines for your kind perusal and necessary action.

That on 25 March 2023, the villagers of Konsakhul have destroyed our Mithun fencing in contravention of the above agreement as stated in annexure A and B.

Two days back the villagers of Leilon Vaiphei under the leadership of Leilon Area Siel (Mithun) Society have erected Mithun fencing in the area as demarcated and agreed upon by five villages as mentioned in annexure A. Unfortunately the Konsakhul villagers have dismantled the hard fencing works of the Leilon villagers.

As public discontent and anger grew in Leilon villages, we detain two persons namely Mr. Rocky Chawang S/O Achun (33 yr) of Lungwuiram (Konsakhul) village and Mr. Langangbou Malangmei S/O Irangbou Malangmei of Konsakhul Village today to enquire as to who have destroyed the aforesaid Mithun fencing unilaterally. The Light Vehicle and the JCB along with two persons were detained as they were approaching towards Konsakhul village, and some unknown persons have caused damaged the two vehicles. The innocent Leilon villagers who are at the receiving end of the Konsakhul villagers conduct cannot remain silent spectator indefinitely.

Therefore, it is submitted that the Police authority is requested to take up the matter as deem fit in the interest of public safety and communal co-existence at the earliest please.
