I have the honour to report that on 03/05/2023 at around 7:30 pm, the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely burn down my house and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

- i. House -Rs. 29,00,000/-
- ii. Mandir -Rs. 55,000/-
- iii. Wooden Almirah 4 face, Iron Godrej 4 Face (2 nos), bed Double (3 nos), Bed Single (1 nos) -Rs. 1,61,000/-
- iv. Duck & Chicken (60 nos), Refregerator, Washing Machine -Rs. 67,000/-
- v. T.V Led Flat, Cylinder & Stove, Utensils, Clothes -Rs. 2,57,000/-
- vi. Cash, invertor, Gold 10 san, Rice 45 bags -Rs. 3,89,500/-
- vii. Documents (ATM card, Bank passbook, certificate of 10 & 12, driving license)

Total approximate value is about Rs. 38,29,000/-approx.

Regarding the matters I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


