- T.V Led Flat, Cylinder & Stove, Utensils, Clothes -Rs. 2,57,000/v.
- Cash, invertor, Gold 10 san, Rice 45 bags -Rs. 3,89,500/vi.
- Documents (ATM card, Bank passbook, certificate of 10 & 12, driving license) vii.
