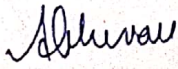

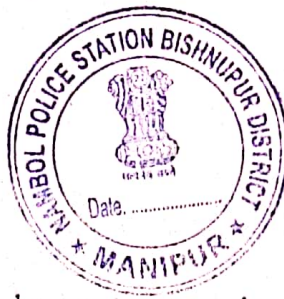

Subject: - Report.

Sir,

I the undersigned have the honour to report that today i.e. 6th April, 2024 at around 5:00 am received a reliable information from F-Coy 33 Assam Rifle regarding the presence of militants hideouts in the general areas of Nambol, Maibam Lotpa Chingmang and Oinam and the same was corroborated from our own source. Accordingly at around 5:30 am, a combined team of A/32 Bn. CRPF, a team of Nambol PS led by Shri Abhinav, IPS (P), OC/NBL-PS, Inspector, M. Jiten Singh and Bishnupur CDO teams led by P. Sanjoy Singh, MPS/DSP (CDO-1), assisted by SI. N. Nandalal Singh, Hav. No. 132001189, N. Seilesh Singh, 7th IRB now attached with CDO-BPR under the overall supervision of Ksh. Ravikumar Singh, IPS, SP/Bishnupur and Amarjit Lamabam, MPS Addl. SP (Ops) Bishnupur conducted a thorough and extensive search operation in Maibam Lotpa Hill area near Maibam Kabui village. During the searched found two plastic sacks and one Rucksack bag. On opening the said bags the following war like store articles were detected-

1. 36-HE. Hand Grenade- 9(nine) nos.
2. Smoke Bomb- 3(three) nos.
3. Walkie- Talkie- 4 (2- Motorola, 1- icon, and 1- Baofeng)
4. One 303 Country made Rifle bearing gun No. Nil.
5. One Carbine bearing No. E-7385 with 2 Magazines
6. One 9 mm country made pistol bearing no. Nil with one magazine
7. 51mm Para Bomb marked as O.D.R.07.09- 5(five) nos.
8. 21 mm HE Mortar- 1(one) no.
9. Two mobile phones-(1- Nokia and 1- Sony)
10. Two smoke bombs marked as 30-DKF 02/16 QCTCP
11. One Tube launcher- 1A
12. Eight live rounds of SLR Rifle
13. Two live rounds of AK Rifle
14. Two live rounds of INSAS Rifle
15. One Helmet
16. Jungle boot- 3 (three) pairs.
17. Sleeping Bag- 1(one) no.
18. Bullet proof Jacket without plate -3(three) Pieces
19. Detonator- 1(one) no.

The above mentioned items which were suspected to be hidden by militants were seized at 8:50 am by observing formalities and handed over to Nambol PS for further necessary action.

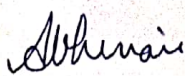
