



Sir,

I have the honour to report that on 03/05/2023 at around 7:30 pm, the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, broke into my father's house and completely burned down and looted much of his properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gamnom Sapormeina

The properties that were burn down and looted are as follows:

- i. House -Rs. 32,00,000/-
- ii. Wooden Almirah 4 face (2 nos), Bed Double (2 nos), Bed Single (2 nos), Refrigerator, Washing Machine - Rs. 1,77,000/-
- iii. Furniture Items, TV, Cylinders (3 nos), Stove, Utensils -Rs. 1,28,000/-
- iv. Clothes, Cash, Gold 9 san - 2,92,000/-
- v. Documents (Aadhar card, Voter ID, ATM, Bank passbook, PMJAY, Ration)

Total approximate value is about Rs. 37,97,000/-approx.

Regarding the matter I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


