

Sir,

With due respect, I the undersigned would like to lay down few lines before you for your kind consideration and necessary action.

That, I am serving under Manipur Police Department 5th IRB Chingarel Tejpur under Rifleman Number 15010690 and attached to State Disaster Response Force (SDRF) Imphal.

That, on 2nd June 2023 at 5:00pm, unknown miscreants belonging to Meitei community, numbering more than 500 people suspected to be members of Arambai Tengol, Meitei Leepun and others have attacked our village i.e. Bethel Village under Kanchup Geljang Sub-Division by holding deadly weapons including automatic rifles and other sophisticated weapons. The miscreants have ransacked and burnt down my Kacha house building and all properties like furniture, kitchen items, clothing, important documents, electronics item, computer, TV, Woofer, paddy rice 90 bags, Poultry and domesticated animals and other properties inside the house. The estimated value of properties lost, ransacked and burnt down by the miscreants is estimated to be Rs.45, 00,000/- (Forty five lakhs only).

I, therefore request you to kindly take necessary action in this regard for which I shall remain thankful to you.
