- Water Pump, Fans (2 nos) -Rs. 15,000/vii.
- Tv Sets -Rs. 30,000/viii.
- Cash & Jewellery -Rs. 50,000/ix.
- Documents (Aadhar card, Pension book, Health card, Voter card, ATM card, Bank X. passbook etc.)
