- Tullu big, Sintex, Weaving machine, Cash, Golf 9 san -Rs. 3,23,000 V.
- Goat (15 nos) -Rs. 1,80,000 vi.
- Pigs (40 nos) -Rs. 15,00,000 vii.
- Documents (Aadhar, Bank passbook, PAN card, Voter ID, PHJAY, Labour card viii. etc)

Total approximate value is about Rs. 36,79,000/-approximately.
