



I have the honour to report that, on 03/05/2023 at around 8:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has completely burnt and looted my House located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Kuccha House burnt - Rs. 6,00,000/-
2. Store room with tools -Rs. 70,000/-
3. Wooden Almirah 2 face -Rs. 18,000/-
4. Iron Godrej 4 face -Rs. 16,000/-
5. TV, washing machine -Rs. 25,000/-
6. Dressing table -Rs. 10,000/-
7. Cylinder and gas Stove -Rs. 9,000/-
8. Utensils and clothes -Rs. 95,000/-
9. Table 2 nos, Roof Tins 4 ban - Rs.53.000/-
- 10.Chicken and duck (30 nos) -Rs. 20,000/-
11. Jewellery and cash – Rs. 54,000/-
- 12.Lost Documents: Aadhar card, ration card, Job card, Atm card, bank passbook and Voter ID

Total approximate value is about Rs. 9,52,000/- approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


