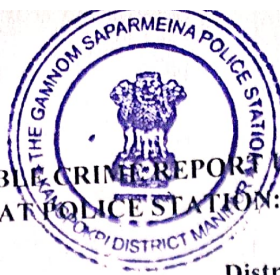





- i. Variety Store -Rs. 1,00,000/-
- ii. Duck & Chicken Centre -Rs. 2,00,000/-
- iii. Refregerator -Rs. 25,000/-
- iv. Electric Heater -Rs. 4,500/-
- v. Table fan -Rs. 3,000/-
- vi. Clothing & Goods -Rs. 6,00,000/-
- vii. Ducks (40 nos) -Rs. 25,000/-
- viii. Chickens (50 nos) -Rs. 40,000/-
- ix. Cylinders (2 nos) -Rs. 8,000/-
- x. Gas Stoves & Bullem -Rs. 5,000/-
- xi. Materials -Rs. 20,000/-

Total approximate value is about Rs. 10,30,500/- approximately.

Regarding the matter I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.
