Sir,

I the undersigned on behalf of Longjam Olen Meitei (17) yrs of Torbung Mangla beg-to state that, my son Longjam Olen went to deliver foods and water for the village volunteers at Awaakla Supermarket areas on 5th August 2023 at around 9:00 am. My son had been volunteering for assistance of the village volunteers of Torbung Mangla since the conflict broke out between the Meitei and Kuki Community in May of 2023. On the very day at around 9:30 am, an incident was happened that suddenly there was gun firing by the Kuki terrorist towards the village of Awaakla Ward no. 8 near masjid where he got two bullets injury on his left knee. Immediately the village volunteers took him to Meirang Community Health Centre for treatment but due to the seriousness of the injury after he was given first aid and then he was refer to Raj Medicity Hospital, North A.O.C Imphal where he got operated.

Regarding the matter, it is my sincere apologies to the Concern authority that I was not able to report in time due to my lack of knowledge and my family problems that we are living in Taxmu Water Sport Complex Relief camp, Laisai village in Changa A.C.

I therefore request you to take up necessary action. Your kind help will remain thankful for our lives.

8. That, now the bullet was in his Left Knee had need to operation. This is true to the best of my knowledge.



4. Tab. HIFINAC P - 1 tab. twice daily after food x 5 days.
5. Tab. CHYMORAL FORTE - 1 tab. twice daily x 3 days.
6. Tab. BIO D₃ MAX - 1 tab. once daily after food x 20 days.


