Today, i.e. 28/03/2023 at 10: 30 am, received a reliable information that on the same day at about 10:00 am, there was a long stand off between the villagers of Konsakhul and Leilon Vaiphei in connection with the dismantled of Mithun fencing by Konsakhul villagers which was constructed by the later leading to scuffle by using sticks, pelting stones, etc. As a result of which several numbers of both the villagers sustained injury on their persons. Immediately, a combined team of Kangpokpi District Police led by SP-KPI, ASP(Ops)-KPI rushed to the said area and fired several rounds of tear gas shells, etc. in the air so as to disperse the mob and to control the situation.
