



I have the honour to report that on 03/05/2023 at around 7:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely burned down my houses located at Motbung Meitie Leikai, Kangpokpi District, P.S Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Semi- Pucca house burnt -Rs. 15,00,000/-
2. Wooden beds (4 nos) -Rs. 80,000/-
3. Wooden Almirah (4 nos) 4 face -Rs. 1,30,000/-
4. Iron Godrej -Rs. 18,000/-
5. Utensils -Rs. 60,000/-
6. Gas stove, 2 cylinder and box -Rs. 25,000/-
7. Clothing and Wooden weaving machine -Rs. 1.05,000/-
8. Jewellery (6 san) - Rs. 75,000/-
9. Cash -Rs. 50,000/-

Total approximate value is about Rs. 20,43,000/-approx.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
