

I have the honour to report that on 03/05/2023 at around 7:40 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, broke into my house and completely burn down and also looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gamnom Sapormeina

The properties that were burn down and looted are as follows:

- i. House -Rs. 6,50,000/-
- ii. Mandir (laishang) -Rs. 2,00,000/-
- iii. Store Room (Outdoor) -Rs. 1,50,000/-
- iv. Furnitures & Wooden Item -Rs. 90,000/-
- v. Godrej 3 face (2 nos) -Rs. 28,000/-
- vi. Electronic Items -Rs. 80,000/-
- vii. Cylinders (3 nos) -Rs. 10,000/-
- viii. Clothing -Rs. 70,000/-
- ix. Utensils & Kitchen Items -Rs. 90,000/-
- x. Cash & Jewelry -Rs. 2,00,000/-
- xi. Misc. - Rs. 50,000/-
- xii. Rice Bag (8 nos) -Rs. 8000/-
- xiii. Ducks & Hen -Rs. 15,000/-

Total approximate value is about Rs. 16,41,000/-approximately.

Regarding the matter I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
