I have the honour to report that on 03/05/2023 at around 7:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc. completely burned and looted my House located at Charhajare, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Pucca House with 2 garage Burnt - Rs. 45,00,000/-
2. Furnitures (Almirah 4 nos, Iron Godrej 2 nos, Dressing Table etc) -Rs. 10,00,000/-
3. Kitchen and Utensils -Rs. 6,00,00/-
4. Clothes -Rs. 3,00,000/-
5. Jewellery -Rs. 10,00,000/-
6. ActivaScooty and Bicycle -Rs. 75,00,000/-
7. Medicine Storage (Rahul Pharmacy MotbungBazar) -Rs. 19,00,000/-
8. Electronic items -Rs. 2,00,000/-
9. Cash Amount -Rs. 4,00,000/-
10. Lost Documents : LIC Nos.6N(F), DHS QP SPT 2019, Insurance Book, Bank (ICICI) passbook, Certificates

Total approximate value is about Rs. 99,75,000/- approx.
