I have the honour to report that on 03/05/2023 at around 7:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has vandalized and looted my houses located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

- i. House - Rs. 7,00,000/-
- ii. Furniture & Wooden Item - Rs. 1,50,000/-
- iii. Godrej 3 face (2 nos) - Rs. 28,000/-
- iv. Electronics Items - Rs. 1,50,000/-
- v. Cylinder (5 nos) - Rs. 15,000/-
- vi. Utensils & Kitchen Items - Rs. 15,000/-
- vii. Jewelry 5 san - Rs. 75,000/-
- viii. Syntex and Firewood - Rs. 3,000/-
- ix. Cash, Activa 6g (MN01 3338), Well - Rs. 4,20,000/-

Total approximate value is about Rs. 16,91,000/- approximately.

Regarding the matter I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.
