The properties that were burn down and looted are as follows:

1. Semi Pucca House - Rs. 15,00,000/-
2. 2 Wooden beds, 3 wooden Akmirah, Steel Godrej, Wooden Sofa Set, Clothing, Utensils, Jewelry and Cash - Rs. 3,60,000/-

Total approximate value is about Rs. 18,60,000/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
