Subject:- Report.

I have the honour to report that on 23/02/2024 at about 3:30 p.m. while a joint team of 16-KUMAON Regt. and a team of PGCI-PS were conducting regular frisking and checking at Kwakta ward no. 8 near Qutub wali Masjid along Gothol road, one Honda Activa maroon in colour b/reg. no. MN04D/9309 which was coming from Pholjang village towards Kwakta bazaar was stopped for checking. On checking, one transparent plastic packet containing 10 (ten) numbers of soap cases were found inside the tool box of the Honda Activa. On opening the soap cases, soap cases were found filled with reddish powder suspected to be Heroin powder packed in transparent plastic separately. On his preliminary examination, he identified himself as Md. Toncha @ Nezimmudin (24) yrs s/o. Md. Kayamudin of Kwakta ward no. 8 (KMC). Accordingly, 10 numbers of soap cases containing the reddish powder suspected to be Heroin powder and Honda Activa b/reg. no. MN04D/9309 and one mobile phone with sim card bearing 7629990952 were seized from his possession on 23/02/2024 at 03:40pm and later, he was arrested from the spot at 03:50pm after observing all formalities. Due to the tense and volatile situation of the area in c/w the present ongoing ethnic clash, the arrested person along with the seized items was brought to the PGCI-PS for further necessary formalities. Further, information was given to the circle executive magistrate, Kumbi for appearing at the PGCI-PS and accordingly, he appeared at the PGCI-PS. In presence of the executive magistrate, the seized 10 soap cases containing the reddish powder suspected to be heroine powder were marked as A1, A2 upto A10 for identification and the respective weight are A1-13gms, A2-11gms, A3-12gms, A4-12gms, A5-12gms, A6-12gms, A7-10gms, A8-12gms, A9-11gms and A10-11gms and the total weight of the seized illegal drugs was found 116 grams excluding the weight of the soap cases and it was put inside cartoon box marked as B which was properly packed and sealed. The arrested persons along the seized items are handed over to you for taking necessary legal action against her as per law.
