




As per endorsed with reference to vide G.D. No. 16/G.SPM PS/2023, Dated 22-03-2023 in connection with the missing report filed by one Raja Bailkoti (40) of Upper Charhajare village, P.O: Motbung, Kangpokpi District, Manipur regarding missing of his daughter Depika (name change), 13 yrs and his niece Diviya (name change), 15 yrs D/O Man Bahadur Bailkoti of Charhajare village from home on the morning of 21-03-2023.

During the course of enquiry, Hue and cry message had been sent to all Osc of Manipur vide signal No. 15/G.SPM PS/2023, Dated 22-03-2023 and through various electronic media. Hectic effort has also been made to trace the 2(two) missing girls by engaging private sourcemen. During the further course of investigation, it is learned that the two missing girls had eloped with 2 (two) non local labourers and are staying at Mapao Thangal village, Kangpokpi District, Manipur. Accordingly, the 2(two) missing girls and the 2(two) non local labourers were retrieved and brought to G.Saparmeina Police Station in presence of women police today i.e. 29-03-2023. On examination, the 2(two) non local labourers were identified as (1) Rahim Uddin @ Rahul (22) S/O Asar Uddin of Alamkhani Blk 2, (Farampasha Pt 1), PO- Singaria, PS: Nilambazar, District-Karimganj, Assam and (2) Rahim Uddin @ Amit (21) S/O Abdul.Khaliq of Sangaria I, PO: Sagaria Pt-I, PS: Nilambazar, District-Karimganj, Assam and revealed to have illicit affairs with the 2(two) missing/minor girls.

I, therefore submitted my report for favour of further necessary action.
